



Navient named “Champion of Board Diversity”

WILMINGTON, Del., Oct. 18, 2018 (GLOBE NEWSWIRE) -- Navient (Nasdaq: NAVI), a leading asset management and business processing services company, was among the greater Philadelphia-area companies recognized by the Forum of Executive Women as a “Champion of Board Diversity.” The award was presented yesterday to companies at the Forum’s annual breakfast, attended by more than 600 area female executives.

“It’s long past time for significant increases in diversity in the boardroom, in the C-suite and in elected office. It’s the right thing to do—and it’s the smart thing to do. Companies that embrace diversity and foster it in their leadership ranks are companies that see an increase in their bottom line,” said Margaret A. McCausland, president of The Forum of Executive Women.

The award recognizes companies that achieved board composition of at least 30 percent women. Navient is distinguished for reaching gender parity in the boardroom. Half of the 10-member board of directors are women.

The organization also released its annual report, [Women in Leadership](#), which provides an important barometer for measuring progress of women leaders in the region. This year’s report reveals that of a total of 870 board seats 17 percent are held by women, only a slight increase from 16 percent in 2016.

“At Navient, we strategically sought the skills we needed from diverse board candidates and are proud that half of our board members are women,” said Navient President and CEO Jack Remondi. “Diversity in the boardroom encourages engagement and challenging assumptions, which we believe is essential to our success.”
